CAMPUS SECURITY AND ACCESS

The hours of campus operations are 6:00 AM to 11:00 PM. Saturdays, Sundays and holidays the hours of operation are 6:30 AM to 10:00 PM for all. Certain classified staff such as Custodial, Food Services, Athletics and Campus Safety who have official business are authorized to be on campus past the hours of operations. For special circumstances such as emergencies, special access is granted to Maintenance, IT and other college staff that have a role in maintaining the continual operations of the College. The College also recognizes that the established hours of operations may be extended for special events, including Civic Center Act use/rentals.

District facilities will be open during business hours. During non-business hours, access to all District facilities is by entry through the District-issued Access card or key, if issued, or by admittance from Campus Security Office personnel.

The District operates public and non-public spaces. Non-public spaces are not open to the general public and include offices, classrooms, laboratories, intercollegiate exercise areas, child day care areas, and other restricted facilities used for educational or administrative purposes. (Also see BP/AP 3900 Speech: Time, Place, and Manner and AP 3415 Immigration Enforcement Activities.)

Emergencies or unforeseen circumstances may necessitate changes or alterations to any posted schedules. Areas that are revealed as problematic will have regular security surveys. Administrators from Business Services, Campus Security, Risk Management, the appropriate Vice President, and other concerned areas will review these results. These surveys examine security issues such as landscaping, locks, alarms, lighting, and communications. Additionally, during the academic year, the Director, Facilities, Risk Manager, Director, Campus Safety, and the appropriate Vice President shall collectively review and address campus security and access issues of pressing concern.

The following additional Criminal Violations as defined by California Penal Code shall permit the arrest or removal of individuals from District Property.



- Criminal mischief as defined under California Penal Code Section 594 as maliciously harming the property of another.
- Public Intoxication as defined under California Penal Code Section 647(f)
- Disturbing the Peace on a College Campus as defined under the California Code Section 415.5
- Criminal Threats as defined under the California Penal Code Section 422
- Battery as defined under the California Penal Code Section 242
- Attempted Battery as defined under the California Penal Code Section 240
- Entry On Campus by Suspended or Dismissed Student or Employee as defined under the California Penal Code Section 626.2
- Withdrawal Of Consent for Person to Remain On Campus Or Facility as defined under the California Penal Code Section 626.4
- Reckless endangerment is defined as conduct that is wrongful, reckless, or deliberate, and likely to result in death or serious bodily harm to another person
